The Client Advisory Committee (CAC) met at 2:03 p.m. on Tuesday, July 10, 2018, in the Brenda Smith Conference Room at Alta California Regional Center (Alta) to discuss: 1) Executive Director's Report; 2) Chair's Thoughts & Time to Share Feedback; 3) Updates; and 4) Public Comments/Announcements. All present provided self-introductions.

Without objection, Michelle Rewerts made the motion to adopt the CAC meeting minutes of June 12, 2018 as submitted.

- Michelle R. read aloud Alta's Vision

1. Executive Director's Report



- Phil shared that it's July, so we are in a brand new fiscal year (FY). Alta has not yet received our initial funding from the Department of Developmental Services (DDS) so we will be borrowing money from our bank in order to pay our bills.
- We received a letter from the Supported Life 2018 Conference Planning Committee informing us that the CAC has been chosen to present at their 32nd Annual October Conference, which will be held on October 4th & 5th, at the Crowne Plaza Hotel in Sacramento. Phil shared that David will be working with volunteers from this group to finalize the presentation entitled "Our Sonoma Journey".
 - Volunteers include: Amy Lampe, Austin Taylor and Kimberly Terrell
 - Phil will help the group get organized and will support them when they present on October 4th.
 - A suggestion was made to invite some of the individuals that have moved out of Sonoma Developmental Center (SDC).

- On June 21st, the last remaining Alta client moved out of SDC.
 - Phil shared the CAC's questionnaire with John Decker and John would like to make a few revisions if the group agrees.
 - The committee reviewed the suggested revisions and were in agreement to them.
 - John will have his staff distribute the revised "Friends Visiting Friends" questionnaire when they meet with the clients at their new homes.
 - John would like to suggest having Debbie Dillon be the volunteer coordinator on this project. Debbie is a nurse, as well as a niece of one of the clients that moved out of SDC.
 - He will invite Debbie to the September CAC meeting so that she can introduce herself to the group.
- The State Fair starts on Friday, July 13th. As in years past, Alta has received free tickets for our clients to attend one of the "Fun for All" days on July 16th or 23rd.
- Amy L. will be giving a presentation on abuse just prior to Alta's Board meeting on July 26th. The Board's annual September Retreat will be held in Yuba City this year.
- Public speaking can sometimes be terrifying and then become so natural for people. If anyone wants to take a risk in a supportive environment, you might want to consider joining Toastmasters.

2. Chair's Thoughts & Time to Share Feedback


Kimberly welcomes any thoughts so that the CAC can continue to be of value to the regional center. She would like everyone to share ideas and move forward as a group of advocates.

 - The Board is starting to make plans for their annual September retreat, which will take place in the Yuba/Sutter area this year.
 - Phil talked about the state budget and shared that the federal government approved California's waiver for the Self-Determination Program.
 - Phil also shared a list of Alta's accomplishments for this past year.
- The next Board meeting is scheduled for Thursday, July 26th, at 4 p.m.
- Alta's Provider Advisory Committee (PAC)
 - Sandy shared that the biggest challenge for service providers right now is
 to have as many providers complete the DDS Rate Survey as possible.
 Providers have been attending hearings at the State Capitol in an effort to
 advocate for the individuals that are served by our statewide service
 system. The PAC surveyed themselves and developed some priorities that
 they have been working on for the past year, one of which is training.
