The Client Advisory Committee (CAC) met on Tuesday, July 11, 2023, at 2:00 p.m. to discuss: 1) Executive Director's Report; 2) Project SAFEE Presentation; 3) Updates; and 4) Public Comments/Announcements. All present provided self-introductions.

Without objection, Amy Lampe made the motion to adopt the CAC meeting minutes of June 13, 2023 as submitted.

# 1. Executive Director's Report



 Lori shared that volunteer committee members are working with Alta's Legal Services Manager, Robin Black, as well as members of the State Council on Developmental Disabilities (SCDD) to develop training modules for Supported Decision-Making (SDM). The group met on June 21<sup>st</sup>, where members volunteered to watch SDM videos that are posted on the Arc website and report back to the entire group at the next meeting scheduled for July 26<sup>th</sup>.

- The workgroup that is updating Alta's client friendly Individual Program Plan (IPP) signature page will share information at the CAC's September meeting.
- The upcoming September 12<sup>th</sup> CAC's Meet & Greet was highlighted in the July edition of *Alta Connections*. A planning meeting is scheduled via Zoom for August 8<sup>th</sup>, from 2 to 3 p.m.
- At the last meeting, the group discussed developing a one-page profile, following the Person-Centered Planning model.
  - Ryan noted the group profile will be posted on our agency's website.
     In the future, the committee may also want to offer individualized profiles, which can be changed out every month.
  - The focus of this one-page profile will be to encourage interest in CAC membership.
  - Thalia shared that she can highlight individual stories on our website and/or social media.

## 2. Project SAFEE Presentation

- A team from the State Council on Developmental Disabilities (SCDD) presented on Project S.A.F.E.E. (Self-Advocates for Emergency Education). They have educated individuals about:
  - Vaccine Hesitancy
  - Emergency Preparedness
- Preparing for an emergency makes sense develop a plan.
  - What are the essential things you need to survive? Make sure that your support network knows where everything is.
  - Have a basic emergency kit ("Go Kit") available at all times.

## 3. Updates

- Peer Advocacy Network (PAN)
  - Today, the group had a presentation about professionalism. They talked about their responsibilities as PAN representatives.
  - Members were encouraged to talk to their Chapters about the upcoming Regional Meeting which will be held at the Wyndham Hotel in Sacramento on Saturday, September 30<sup>th</sup>.
- ◆ ARCA-CAC
  - The group met on June 30<sup>th</sup> and talked about what to do if you are being robbed or mugged.
  - The next meeting is scheduled for July 28th from 10 to 11 a.m.
- ◆ DDS-CAC
  - The group met on June 14<sup>th</sup> and discussed the Self-Determination Program (SDP). Members will also be completing a survey.
  - They plan to hold in-person meetings in 2024.
