Alta California Regional Center (ACRC), serving individuals with developmental disabilities, and its Stakeholders have identified a need to develop multiple projects in order to better serve individuals who have high support needs. See below for a brief description of each project.

## Fiscal Year 2024-2025 CPP/CRDP Projects:

Specialized Residential Facility (SRF) for Stepdown Placements for Adults (Project ID: <u>ACRC-2425-3)-CRDP</u>. Development of a 4-bed adult residential facility to step down adult clients down from an Enhanced Behavior Support Homes (EBSH) or Community Crisis Homes (CCH) facility.

**Psychiatric Treatment (Project ID: ACRC-2425-4)-CRDP**. The development of mental health services offering a variety of services including prescribing medications, registered nurse to complete injectables, and a wellness center for on-going support with anger management, meditation, self-care, mindfulness, basic conversation skills, community re-entry, friendship and intimacy, medication management, recreation for leisure, substance abuse management, symptom management, workplace fundamentals, involving families in mental health, etc.

**Dental Services (Project ID: ACRC-2425-5)-CRDP**. Development of an app designed to assist clients with improving their ability to tolerate and receive dental care in a dental office and at home.

**Dental Services (Project ID: ACRC-2425-6)-CRDP**. Development of a dental desensitization service with support from a BCBA and/or RBT, and a dental hygienist to assist clients with being able to tolerate dental hygiene and less reliance on sedation.

Specialized Residential Facility (SRF) for Stepdown Placements for Children (Project ID: <u>ACRC-2425-7)-CRDP</u>. Development of a 4-bed Group Home to step down children down from an EBSH or CCH facility.

**Day Program (Project ID: ACRC-2425-8)-CRDP**. Development of a behavior day program that will also assist clients with some medical needs and personal care. The preferred location will be an outlining area such as El Dorado, Nevada County, Sutter, Colusa, Yuba, Yolo, etc.
