- COI Policy Review comments and plan for 2018.
  - Mr. Lake shared that with the review of ACRC's Conflict of Interest Policy at the July meeting, and the committee's requirement of submitting them to DDS by August 1<sup>st</sup> of every year, he realized that the Board should have a plan in place to streamline the process for future years.
    - Moving forward, Ms. West will distribute copies of the COI statements to Board members on July 1<sup>st</sup> of each fiscal year (FY).

### 3. New Business

- Policy Review
  - ACRC's "Approval of Contracts in Excess of \$250,000" Policy was distributed for review. Mr. Lake read the policy aloud.
    - Mr. Bonnet noted that ACRC may have some clients that require more than \$250,000 in Purchase of Services (POS), based on their Individual Program Plan (IPP). The Board is not responsible for approving POS authorizations.
- Possibly waive bylaw Section 4.02 for Treasurer for 2017-18 FY
  - Mr. Safvi has served as ACRC's Board Treasurer for the last three FYs. His job transferred him to San Francisco, that is why he has been absent from several meetings.
  - Mr. Lake would like permission from this Board to waive Section 4.02 in the agency's bylaw so that Mr. Safvi can serve as the Board's Finance Committee Chair for the current FY.
