The Finance Committee met at 3:00 p.m. on Monday, January 12, 2015, in the Brenda Smith Conference Room at Alta California Regional Center to discuss: 1) Review Independent Audit Report; 2) Monthly Financial Report; and 3) Contract of \$250,000 and above. All present provided self-introductions.

**Without objection, Anwar Safvi made the motion to adopt the Finance Committee meeting minutes of September 8, 2014 as submitted.**

**1. *Review Independent Audit Report***

**Issue:** The committee needs to review ACRC's independent audit report for the 2013-14 FY.

**Discussion and Action:** Mr. Tiedemann distributed the "Independent Auditors' Report" for review. Mr. Christensen reviewed the audit report including the basic financial statements with those present. He noted that ACRC's management is responsible for the preparation and fair presentation of these financial statements, while the auditors are responsible to express an opinion on them. In their opinion, Thompson Noble Company, LLP believes the financial statements represent fairly, in all material respects, the financial position of ACRC as of June 30, 2014.

The auditors make additional notes to summarize significant accounting policies, such as contributions, equipment, and accrued vacation benefits. They also make notes on contracts, retirement plans, cash, lease commitments, line of credit, fair value measurements, and subsequent events.

Mr. Christensen believes ACRC's management has done a good job.

## **2. Monthly Financial Report**

**Issue:** The monthly financial report is reviewed by the Finance Committee prior to presentation to the Board.

**Discussion and Action:** Mr. Tiedemann distributed the November 30, 2014 financial report which reflects five month of expenditures for the current fiscal year (FY). ACRC has expended 42.2% of Purchase of Services (POS) and 42.7% of Operations (OPS).

Mr. Tiedemann is projecting that ACRC will need between \$21.7 and \$24.1 million in additional POS funding this FY. This amount includes approximately \$1.8 million for a rate increase for Supported Living and Respite vendors that may not occur due to legal challenges. He noted that the Department of Developmental Services (DDS) has changed their allocation methodology. Mr. Tiedemann explained that part of the deficit is due to the minimum wage increase; the department has funded us less than what it is costing us to implement. Also, there has been growth in several areas of service.

Statewide, our service system is in need of \$300 million in additional POS funding for the current FY. Mr. Tiedemann believes our POS deficit may decrease over time. ACRC is hosting the Association of Regional Center Agencies' (ARCA's) meetings later this week and we should learn more statewide information about the POS deficit at that time.

**Without objection, Anwar Safvi made the motion to accept the monthly financial statement as submitted.**

## **3. Contract of \$250,000 and above**
