- 11) Update on Waiver Application and Statewide DDS Workgroup (Rydquist/Bingaman)
  - a. DDS posted the Self-Determination Waiver on August 7 for 30 days of Public Comment. In mid-September, DDS will submit the Waiver to CMS. CMS will then have another 90 days to respond. There could be additional delays at any point in the process. It seems unlikely the waiver will be approved in less than 4-5 months.
- 12) What is an Independent Facilitator (Judy Mark) Judy Mark of the Autism Society of Los Angeles gave a presentation on the Role of the Independent Facilitator (IF). It is voluntary for a consumer to use an Independent Facilitator. The Service Coordinator can act as the IF. The IF cannot be providing services or employed by an agency providing services to the consumer. The consumer can use the IF a little or a lot depending on their needs. In the first few months/years, the consumer may need more assistance locating, negotiating, and setting up services. Once services are set up, there may be less need for the IF. Parents can act as the IF. In some cases parents act as the IF for other families. The IF helps with the Person Centered Planning Process. They need to have the ability to introduce resources, access generic resources and free resources in the community. The IF must be familiar with CMS/HCPS Settings Rules so that services developed are integrated and will be approved and reimbursed. The IF helps to negotiate rates with providers. The IF assists during life changes or crises. The IF can assist with transition planning, during a health crisis, and to assist with requesting an adjusted budget. They assist and support the consumer to manage their services. They can charge an hourly or monthly fee. There have been several IF trainings in California.

More will be needed. Local areas need to coordinate these trainings.
