# Fiscal Year 24/25

- **Community Placement Plan (CPP)**
  - Reduce reliance on developmental centers and Institutions for Mental Disease (IMD)
  - return individuals home when relocated out-of-state residential resources
  - deflect individuals from moving into “restrictive living arrangements.”
- **Community Resource Development Plan (CRDP)**
  - Increase community capacity, making it possible for individuals with intellectual and developmental disabilities (I/DD) to live, work and recreate inclusive community settings.
  - Provide a variety of residential options and services and supports to meet services and supports needs identified in the Individual Program Plan.




## Goals:

ACRC's goals for CRDP are to be responsive to the changing needs of the individuals we serve through an expanded capacity of services and supports designed to meet those changing needs. The goal is to meet the unmet and under met needs of our clients.

**Goal One:** *Develop services that are person-centered, specialized, and represent cultural and linguistic diversity throughout the regional center's catchment area.*

**Goal Two:** *Develop systems to ensure that quality services and supports, in the least restrictive environment are provided to individuals in the community.*

**Goal Three:** *Expand the availability, accessibility, and types of services and supports to meet current and future needs of individuals and their families in the community*
