

#### SELF DETERMINATION PROGRAM UPDATE Prior to enrollment in the Self Determination Program, ACRC

Prior to enrollment in the Self Determination Program, ACRC will support the client in funding for a Person-Centered Planner and an Independent Facilitator. The Department of Developmental Services has provided multiple options regarding funding for pre-enrollment supports. The funding options are listed below and the vendored service providers can be found on the following page.

## Option A

\$2500 towards initial PCP creation and transition supports under 024 reimbursement.

Providers utilizing this option must stop accepting new clients by 11/1/24.

### Option B

\$1000 towards initial PCP creation (through 024 reimbursement).

Up to 40 hours of Self-Directed Supports to facilitate the transition from traditional services into the Self Determination Program. This is accessed through either ACRC vendored Independent Facilitators *or* non-vendored providers with Participant-Directed Services.

\*Providers accessed as Participant-Directed Services do not have to be an ACRC vendor and will be paid through an FMS.

#### FMS Transition Support NEW!

Additional support from FMS to clients initially enrolling in SDP, transferring from one FMS to another, or transferring from one regional center to another.

May support in coaching participants on employment laws and responsibilities, reviewing monthly budget report, and understanding adjustments to budget and spending plan.

May assist with hiring/onboarding staff through educating on how to interview and write job descriptions, obtaining background checks, educating on EVV requirements, and verifying services are HCBS compliant.

May communicate with Regional Center regarding e-billing and other RC processes.

Up to 3 months of support can be used in addition to 40 hrs of selfdirected supports.
